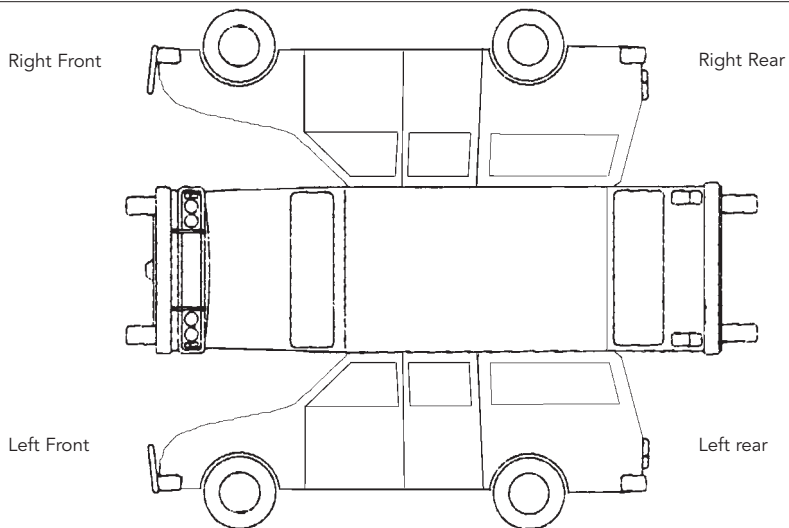

# BUYBACK GUARANTEE TERMS AND CONDITIONS

These terms & conditions are designed to instill confidence in the Buyback System. We have attempted to make the Terms & Conditions as simple as possible, while at the same time clear and comprehensive enough to avoid future disputes. Follow the Terms & Conditions set out below and you will discover that the Travellers Auto Barn Buyback is indeed GUARANTEED.

- 1) **SERVICING:** Your vehicle must be serviced every 5,000km. Receipts from a licensed motor vehicle repairer must be produced as the minimum evidence of servicing. \$150 will be deducted for every service missed. Further penalties apply if it appears the car and particularly the engine has suffered as a result of negligent servicing.
- 2) **REGISTRATION:** It is your responsibility to keep your vehicle registered. Unregistered vehicles will not be accepted and the Buyback Guarantee will be void.
- 3) **DAMAGE:** Any damage to body panels, underbody, windows, lights, bumpers or door handles requiring repairs to bring the vehicle back to the standard at which it was sold will be paid for by the owner or deducted from the Buyback Price.
- 4) **CLEANING FEE:** A cleaning fee of \$100 may be charged for vehicles returned in an unclean state.
- 5) **FINE ADMINISTRATION FEE:** A \$50 Administration Fee will be deducted from the Buyback Price for every Traffic Infringement Notice (fine) sent to Travellers Auto Barn, incurred by you during your period of ownership, and requiring a Statutory Declaration by Travellers Auto Barn, stating that it was not us, but it was you (yes, we name you!) that incurred the Fine.
- 6) **ONE WAY BUYBACK FEE:** You must nominate your intended Buyback Location on the front page of this Agreement. A fee of **\$200** is applicable to all One-way Buybacks (i.e. purchase in Sydney, buyback in Cairns). This fee will be deducted from the Buyback Price appearing on the front page of this Agreement.
- 7) **CHANGE OF LOCATION FEE:** You cannot change your nominated Buyback Location without asking permission. Permission may be granted at the sole discretion of Travellers auto Barn. If permission is granted a **\$250** Change of Location Fee will be deducted from the Buyback Price. This fee is additional to all other fees and charges, including the One-Way Buyback Fee if applicable.
- 8) **OPEN OPTION FEE:** If you would like a choice of buyback locations you can elect to pay a **\$200** Open Option Fee in advance, which will allow you to exercise your Buyback Guarantee either in **Sydney, Melbourne, Brisbane, Cairns, Perth or Darwin.**  
**FOR EXAMPLE:**  
**ROUND-TRIP BUYBACK:** No fee.  
**ONE-WAY BUYBACK:** **\$200** to be deducted from the Buyback Price.  
**CHANGE OF LOCATION & ROUND-TRIP BUYBACK:** \$250 to be deducted from the Buyback Price.  
**CHANGE OF LOCATION & ONE-WAY BUYBACK:** **\$450** to be deducted from the Buyback Price.  
**OPEN OPTION FEE:** \$200 payable in advance at time of sale.
- 9) **BUYBACK PRICE:** The Buyback Price is not a sliding scale. You must nominate the length or period of ownership of the vehicle **at the time of pick-up and this will determine your contracted Buyback Price.** Vehicles returned early are not eligible for an increase in the Buyback Price, unless permission has been sought and granted in writing from Travellers Auto Barn at the time of sale.
- 10) **AWN POLICY:** **If you have chosen to purchase an AWN policy for your vehicle, you are required to return the AWN policy booklet with your vehicle when claiming your buyback. Failure to do so will incur a \$150 fee being deducted from your buyback.**

## EXERCISING YOUR GUARANTEED BUYBACK

- 1) You must telephone the Sydney office one week in advance to arrange a date and time. You will receive a reference number. Please write this number down in the space provided as proof of your booking. Each day short of the required 7 days notice will incur a \$50 decrease in your Buyback Price, if your early return can be accommodated. Early returns are at the sole discretion of Travellers Auto Barn.

- 2) Vehicles will only be accepted for Buyback between 0900-1200 Mon-Fri (not on Public Holidays.)
- 3) Allow approximately 2 hours for the Buyback process as the car must be inspected and the paperwork processed.

## CAMPING EQUIPMENT

Travellers Auto Barn **will** Buyback selected items of camping gear for **60%** of the purchase price at the conclusion of your trip. You must produce receipts as a proof of purchase. There is a limit of \$200 allowing a maximum Buyback price on camping gear of **\$120**. Selected camping gear includes large items such as coolboxes, cookers, chairs, tables, jerry cans (water or fuel), tents, pots and pans, etc., and excludes items such as sleeping bags, pillows, linen, roll mats, and small items of assorted non-essential equipment. If you have camping gear without receipts we will make you an offer, which you are free to accept or refuse.
